WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is the principal government agency tasked to raise and provide funds for health programs, medical assistance and services, and charities of national character;

WHEREAS, pursuant to the Bayanihan to Heal as One Act, it is the thrust of the administration of His Excellency President Rodrigo Roa Duterte, to provide medical facilities for emergency services, health care programs and social services following the increasing confirmed COVID-19 cases throughout the country;

WHEREAS, Pursuant to Republic Act 9997, Article II, Section 8(c) states that the National Commission on Muslim Filipinos (NCMF) shall act as the primary agency through which Muslim Filipinos can seek assistance and redress;

WHEREAS, accordingly, the PCSO Chairperson Anselmo Simeon P. Pinili approved the donation of one (1) ambulance unit to National Commission on Muslim Filipinos, after having been found as qualified recipient under the 100% PCSO Ambulance Donation Program, thus on motion of the Honorable Commissioners;

NOW WHEREFORE, in view of the foregoing considerations, the Commission, by way of ad referendum:

RESOLVES, as it hereby RESOLVED, that the Honorable Secretary Saidamen B. Pangarungan be authorized to sign the Deed of Donation with the Philippine Charity Sweepstakes Office for the acceptance of one (1) ambulance unit;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Honorable Secretary Saidamen B. Pangarungan for appropriate action and the PCSO Chairperson Anselmo Simeon P. Pinili, for information and guidance.
