RESOLUTION NO. 03, SERIES OF 2024

AN ENBANC RESOLUTION RECOMMENDING TO THE OFFICE OF THE PRESIDENT THE REAPPOINTMENT OF FOUR (4) COMMISSIONERS

WHEREAS, RA 9997 states that the Commission shall preserve and develop the culture, tradition, institutions, and well-being of Muslim Filipinos, in conformity with the country's laws and in consonance with national unity and development;

WHEREAS, the same law provides that the Commission shall be composed of nine (9) full-time members who are Muslim Filipinos and shall be headed by a Secretary: *Provided*, That one (1) of the Commissioners shall come from the women sector, one (1) from the youth sector and another Commissioner shall come from the Ulama sector: *Provided, further*, That not more than two (2) Commissioners shall come from the same Muslim Filipino tribe at any given time, to ensure a more equitable representation in the Commission;

WHEREAS, RA 9997 provides that the Commissioners shall be academic degree holders and must speak and write fluently the English and/or Arabic languages. They shall be individuals who possess the highest, degree of integrity and have the endorsement of their respective tribes or sectors;


WHEREAS, on March 7, 2024 four (4) of the Commissioners will be expiring their term, hence a vacuum may arise pending appointment of the new set of Commissioners;

WHEREAS, in order to prevent paralysis of the performance of the essential mandate of the Commission and hiatus in the leadership, the Commission must recommend to the Office of the President the reappointment of incumbent Commissioners whose term will expire on March 7, 2024;

NOW, WHEREFORE, the Commission **RESOLVES** as it is hereby **RESOLVED**, to recommend to the Office of the President the Reappointment of the following Commissioners:

1. Jamal S. Munib for *Ulama Sector*
2. Ismael V. Mastura for *Maguindanaon Tribe*
3. Samer M. Allong for *Youth Sector*
4. Yusoph J. Mando for *Yakan Tribe*


