RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO GILCOR PRINTING PRESS FOR THE PRINTING OF GAD MANUAL ON MENTAL HEALTH AND PSYCHOSOCIAL SUPPORT FOR MUSLIM FILIPINOS
(Reference: RFQ 2017-04-005)

WHEREAS, the NCMF-Bids and Awards Committee prepared the terms of reference and purchase request for the Printing of GAD Manual on Mental Health and Psychosocial Support for Muslim Filipinos through Small Value Procurement –Alternative Methods of Procurement for an Approved Budget for the Contract (ABC) of ONE HUNDRED THIRTY TWO THOUSAND SEVEN HUNDRED FIFTY PESOS (P132,750.00) which is included in the Annual Procurement Plan of the NCMF for CY 2017;

WHEREAS, the BAC invited the following prospective suppliers through issuance of Request of Quotation: Ejess Trading, Alva Digital Services, DGR Bookbinding & Photocopying Services, Colorplus Production Group Corp., Erzalan Printing Press, King Phil Printing Services, Best Shot Printing and Gilcor Printing Press.

WHEREAS, based on the evaluation of the Technical Working Group, the proposal of Gilcor Printing Press conforms to all the technical specification requirements of NCMF and the law, and its price quotation of SEVENTY SEVEN THOUSAND FOUR HUNDRED PESOS (P77,400.00), which is within the ABC, is the most economical and advantageous to the Government, thereby rendering the same as the lowest calculated and responsive bid.

WHEREAS, Section 12 of R.A. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.


- (1) **AWARD OF CONTRACT** via Small Value Procurement to Gilcor Printing Press the printing of Gender and Development Manual on Mental Health and Psychosocial Support for Muslim Filipinos in the amount of P77,400.00;
- (2) **APPROVAL** from the HOPE to grant Notice of Award and Notice to Proceed to implement this Resolution.


