TERMS OF PREFERENCE:

The prospective bidders shall bid for the supply and delivery of purified drinking water to the National Commission on Muslim Filipinos with office address at #79 Jocfer Bldg., (Annex) Commonwealth Avenue, Diliman, Quezon City.

I. DELIVERABLES/REQUIREMENTS FROM THE SUPPLIERS

- 1. The aforementioned quantity may be increased or decreased by NCMF based on its actual requirements.
- 2. The supplier shall provide ten (10) units of brand new hot and cold water dispensers to NCMF during contract implementation at no cost to NCMF.
- 3. Upon submission of bids, the supplier shall submit certified true copies and present the original copies of the certification that it has passed the microbiological/bacteriological test undertaken by Maynilad/Manila Water and a DOH-accredited water testing laboratory within the last thirty (30 days) and physicochemical tests undertaken by a DOH-accredited water testing laboratory within the last three months.
- 4. The supplier shall also submit a Certificate of Potability issued by the Local Government Unit's (LGU) Health Office.
- 5. Upon implementation of the contract, the supplier shall regularly submit certified true copies and present the original copies of the certification that it has passed the abovementioned water tests. The schedule are cited below:

- 6. The supplier shall conduct maintenance/cleaning of all the hot and cold water dispensers twice a month or as may be required by the NCMF.
- 7. The supplier shall allow NCMF to have access to its facilities during the conduct of an ocular inspection of its water refilling station before contract implementation.
- 8. The supplier shall conduct a one-day training on the proper handling of water containers and maintenance of water dispensers.

II. SCHEDULE OF DELIVERY

The supplier shall deliver the purified drinking water to NCMF not later than 8:00 a.m. twice a week or as may be required by NCMF.

III. CONTRACT COSTS AND PAYMENT

- 1. All bid prices shall be considered as fixed price, and therefore not subject to price escalation during contract implementation.
- 2. Payment shall be made every end of the month.
- 3. Contract duration is (7 1/2) months upon execution of the contract (May 15-December 2018).
- 4. Approved budget for the contract is (P105,000.00).
