**AWARDING TO PHILIPPINE AIRHAWK SECURITY AGENCY INC.,  
THE CONTRACT FOR SECURITY SERVICES**

**WHEREAS**, the Commission is in need of security guards to be supplied by a duly registered security agency;

**WHEREAS**, the Commission has a remaining Approved Budget for the Contract (ABC) in the amount of ONE MILLION THREE HUNDRED SIXTY EIGHT THOUSAND PESOS (P1,368,000.00) for the period: June 2017 to December 2017;


**WHEREAS**, for the foregoing purposes, the Commission through its Bids and Awards Committee has published in the Philippine Government Electronic Procurement System (PhilGEPS), NCMF Website and three (3) conspicuous places in the office the Invitation to Apply for Eligibility and to Bid for the security guards the Commission needed;

**WHEREAS**, THE Philippine Airhawk Security Agency, Inc. has responded to the Commission's invitation to apply for eligibility and to bid, and interestingly, its bid amount was ONE MILLION TWO HUNDRED FIFTY TWO THOUSAND FOUR HUNDRED TWENTY & 03/100 PESOS (P1,252,420.03) which is less by ONE HUNDRED FIFTEEN THOUSAND FIVE HUNDRED SEVENTY NINE AND 97/100 PESOS (P115,579.97) of the Commission's ABC;


**WHEREAS**, adopting the Single Calculated/Rated Responsive Bid scheme which, under the procurement law, may be resorted to, the Committee has resolved to award the contract to the Philippine Airhawk Security Agency Inc.;

**WHEREFORE**, in view of the foregoing considerations, and upon the joint motion of all the members of the Committee, which was unanimously seconded, the Committee **RESOLVES**, as it is hereby **RESOLVED**, awarding the contract for security services to the Philippine Airhawk Security Agency, Inc. in the amount of ONE MILLION TWO HUNDRED FIFTY TWO THOUSAND FOUR HUNDRED TWENTY & 03/100 PESOS (P1,252,420.03).


