HOTEL and/or HOUSING ACCOMMODATION IN MAKKAH

 The distance and the category of the building/hotel/housing being offered must be in accordance with the specifications indicated hereunder, namely:

The hotels offered must have a 4-star or 5-star rating, with a distance of not more than 5 kilometers from hazam, with a provision for a 24-hour round the clock shuttle bus service. The hotels must be close to each other within the same area.

2. All submitted quotations must include the following attachments: colored pictures (size A4) of the building facade, a sample hallways, the entrance lobby, and some rooms, as well as room measurements in square feet or square meters, the maximum capacity per room. Photos of the bathroom and failets, security features, as well as the number of elevators, should also be included.

A locator map, with Al-Masjid A'-Haram as point of reference, of the building must likewise be included.

- The award of contract shall be made to the lowest quotationthat complies
