HOTEL and/or HOUSING ACCOMMODATION IN MAKKAH

 The distance and the category of the building/hotel/housing being offered must be in accordance with the specifications indicated hereunder, namely:

The holeis offered must have a 4-star or 5-star rating, with a distance of not more than 5 kilometers from haram, with a provision for a 24-hour round the clock shuffle bus service. The hotels must be close to each other within the same area.

2. All submitted quotations must include the following aftachments: colored pictures (size A4) of the building facade, a sample hallways, the entrance lobby, and some rooms, as well as room measurements in square feet or square meters, the maximum capacity per room. Photos of the bathroom and loilets, security features, as well as the number of elevators, should also be included.

A locator map, with Al-Masjid Al-Haram as point of reference, of the building must likewise be included.

- The award of contract shall be made to the lowest quotation that complies with the specifications and the terms and conditions stated in this Request For Quotation/Request for Proposal including the company specifications.
