DECLARATION OF FAILURE OF BIDDING FOR PURCHASE OF OFFICE SUPPLIES AND EQUIPMENT OF THE PERFORMANCE GOVERNANCE SYSTEM (PGS)

WHEREAS, the Planning Service as the end-user prepared the specifications for the Purchase of Office Supplies and Equipment of the Performance Governance System (PGS) with an Approved Budget for the Contract (ABC) of **SIXTY-FOUR THOUSAND SEVEN HUNDRED NINETY PESOS (P64,790.00)** and the source of fund will come from the Government of the Philippines (GOP) under General Appropriations Act of 2019 and included in the NCMF 2019 Annual Procurement Plan (APP);

WHEREAS, Sec. Rule XVI of the Revised IRR of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's Annual Procurement Plan (APP);

WHEREAS, on 04 October 2019, the Planning Service as the end-user sent the Request for Quotation (RFQ) No. 2019-075 to: (a) Office Warehouse Inc.; (b) Upson International Corp.; and (c) Urquan Inc. and on the same date were posted at NCMF website and conspicuous places in the office;

WHEREAS, after careful evaluation of the Technical Working Group (TWG), NO BIDDER has complied with the specification requirements of the end-user;

WHEREAS, under Section 35.1 (b) of the IRR of RA 9184, the BAC shall declare the bidding (procurement) a failure when all prospective bidders are declared ineligible;


NOW, THEREFORE, in view of the foregoing, WE, the members of the NCMF-BAC, hereby RESOLVE, as it is hereby RESOLVED to declare FAILURE OF BIDDING for the Purchase of Office Supplies and Equipment of the Performance Governance System (PGS)


RESOLVED FURTHER, that this Resolution be forwarded to the Head of Procuring Entity (HoPE) for his information and appropriate action.
