TERMS OF REFERENCE

FOR THE ENGAGEMENT OF SERVICES OF A CONSULTANT FOR THE CREATION OF INFORMATION SYSTEMS FOR THE NATIONAL COMMISSION ON MUSLIM FILIPINOS (NCMF)

1. The National Commission on Muslim Filipinos (NCMF) intends to procure and engage a consultant's services in the field of Information and Communications Technology for the creation of Information Systems (IS).

2. OBJECTIVE AND SCOPE OF WORK

To establish a Terms of Reference (TOR) for the provision of Information Systems for the selected process of the NCMF.

It will cover the automation of the issuance of Certificate of Tribal Membership (CTM) and Human Resource (HR) processes.

To ensure the smooth and timely implementation of Information Systems.

3. CONSULTANT DELIVERABLES

Conduct a review of the status of the existing process for the issuance of Certificate of Tribal Membership and Human Resource documentation;

Provide technical guidance on addressing the gaps and areas for the automation/improvement identified on the review specified above;

Provide assistance in establishing a Terms of Reference (TOR) for the provision of Information Systems for the above-cited processes.

Provide assistance in the implementation of the Information Systems.

4. TRAINING AND CONSULTANCY ACTIVITIES

The Consultant shall conduct and spearhead below activities for the creation and implementation of Information Systems:

- a) Review of the status of the priority process for automation
- b) Workshop on the flow of the target processes (CTM and HR)
- c) Technical guidance on addressing the gaps and areas for the automation/improvement of the two (2) processes
- d) Technical advice on the finalization of the Terms of Reference (TOR) of Information Systems
- e) Deployment of Information Systems

The Consultant shall also provide the timelines of activities listed above.

5. CONDITIONS AND RESPONSIBILITIES

The CONSULTANT shall:

• Conduct and facilitate the project deliverables within the agreed timeframe;

- Prepare the program and workshop designs for all the activities specified in the training and consultancy activities;
- Review the activity/workshop outputs and recommend necessary modifications for the creation of the IS:
- Provide technical advice and guidance to the End-user in the establishment and implementation of the Information Systems.

The NCMF shall:

- Designate a counterpart support team who will work closely with the CONSULTANT regarding technical and administrative requirements of the project, including the monitoring of the progress of the various activities;
- Provide logistical requirements of the project such as training and meeting venues, accommodation (when necessary), equipment (including LCD projector with desktop or laptop, computers with video conferencing software, and other items, as mutually agreed), supplies, reproduction of training materials for participants, and meals and snacks of participants and the CONSULTANT;
- Ensure that all participants have the necessary equipment (e.g., hardware and software, speakers, microphones, webcams, etc.) and reliable and uninterrupted
- internet connection to participate in all virtual sessions;
- Ensure implementation of relevant activities and provide End-user's support for the implementation of the Information Systems;
- Ensure availability and participation of staff/participants concerned during the conduct of the workshops and other activities necessary in the course of the project;
- Pay the project cost of Two Hundred Sixty Thousand Pesos (PHP 250,000.00) to the CONSULTANT according to the engagement fee schedule.

6. ENGAGEMENT FEE

- a. Financial proposals shall not exceed the Approved Budget for the Contract (ABC) of TWO HUNDRED FIFTY THOUSAND PESOS ONLY (P250,000.00) and shall be deemed to include the cost of all taxes, duties, fees, levies, and other charges (if any) imposed under applicable laws.
