**AN EN BANC RESOLUTION EXPRESSING PROFOUND APPRECIATION
AND GRATITUDE TO PRESIDENT RODRIGO ROA DUTERTE FOR
RECENTLY APPOINTING MUSLIM TOP OFFICIALS IN GOVERNMENT
AND THEREBY GIVING HIM AWARD OF RECOGNITION/APPRECIATION**

WHEREAS, President RODRIGO ROA DUTERTE, has created history as the lone president in the Philippine Republic who comes from Mindanao;

WHEREAS, President RODRIGO ROA DUTERTE has been very supportive of the well-being of the Muslim Filipinos as he lays the foundation of continuous peace and prosperity in Mindanao for signing the Bangsamoro Organic Law;

WHEREAS, this Commission, being a government agency that is tasked "to ensure the rights and well-being of Muslim Filipinos with due regard to their beliefs, customs, traditions, and institutions, as well as to further ensure their contribution to national goals and aspirations and to make them active participants in nation-building" noted the President's role of supporting projects and programs for the welfare of the Muslim Filipinos;


