


2. The SECOND PARTY shall:

Contract of Catering/Function Room Services

Know All Men By These Presents:

This contract of Catering Service is executed this 22 AUG 2022 day of August 2022 in Quezon City by and between:

The National Commission on Muslim Filipinos (NCMF), a government agency, is duly constituted and exists by virtue of RA 9997 with the principal office address at No. 79 Jocfer Annex Building, Commonwealth Avenue, Diliman, Quezon City, represented by **DIR. CEAZAR M. MARANDA**, Acting Director, Bureau of Muslim Cultural Affairs, National Commission on Muslim Filipinos herein referred to as the FIRST PARTY;

- and -

The Great Eastern Hotel Inc., a private company, with the office address at 1403 Quezon Avenue, West Triangle, Quezon City, represented by **PRESIDENT NATHALIE M. NG** herein referred to as the SECOND PARTY.

- Witnesseth -

Whereas, the NCMF is conducting and administering the Testimonial Dinner on 23 August 2022, and as per government procurement rules and regulations the 2nd party's catering service/function room was approved under the BAC resolution No. and requested the catering service with the use of the function room of the Second Party at 1403 Quezon Avenue, West Triangle, Quezon City, as the venue;

Whereas, the Second Party agreed to accommodate the catering activities for the First party base on the 1st party requirements as posted in the conditions below.

Now, therefore, and in consideration of the foregoing, the parties hereby agree under the following terms and conditions, to wit:

1. The FIRST PARTY SHALL:

- 1.1 Contract the catering services of the SECOND PARTY in providing Halal Foods for 225 people or more, depending on the number of people in attendance during the said programs and activities;
- 1.2 Pay the Catering Services and Function Room of the SECOND PARTY with minimal charges in the amount of **One Hundred Two Thousand Eight Hundred Fifty Pesos (Php102,850.00)** for the following services: a. 3 hours use of the Function room; Halal food for 225 heads consisting of Corn Soup, Fried Chicken Chunks, Fish Fillet in Sweet and Sour Sauce, Vegetable and Chicken spring roll, Seafood Pancit Canton, Plain Rice, Buchi, one round assorted soft drinks, 50pcs cupcakes for 100 guests, and PA system with two microphones;
- 1.3 Supervise the implementation of catering services;
- 1.4 Request additional food if necessary.
