## CONTRACT FOR ANNUAL LICENSING OF A DIGITAL TRIBAL CERTIFICATION SYSTEM

## CONTRACT AGREEMENT

    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental of Bid Bulletins, if any
  - Winning Bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- IV. Notice of Award of Contract; and the Bidder's conforme thereto; and
- V. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning Bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of One Million Seven Hundred Four Thousand Nine Thousand Nine Hundred Pesos (PHP1,749,900.00) or such other sums as may be ascertained, TIMEFREE INNOVATIONS, INC. agrees to perform works for the ANNUAL LICENSING OF A DIGITAL TRIBAL CERTIFICATION SYSTEM in accordance with his/her/its Bid.
- 4. The **NATIONAL COMMISSION ON MUSLIM FILIPINOS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
