

Contract Agreement Form

THIS AGREEMENT made the DEC 29 day of 2022 between **NATIONAL COMMISSION ON MUSLIM FILIPINOS** of the Philippines (hereafter called "the Entity") of the one part and **TIMEFREE INNOVATIONS, INC.** of Unit 3B Trans-Phil House, 1177 Chino Roces Ave. Cor. Bagtikan St. San Antonio, Makati City of the Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PROCUREMENT OF ECTM CLOUD SERVICE** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIX HUNDRED FORTY FIVE THOUSAND PESOS (Php 645,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed ton form and be read and construed as part of this Agreement, viz:
 - (a) The Bid Form and the price schedule submitted by the Bidder;
 - (b) The Schedule of Requirements;
 - (c) The Technical Specifications;
 - (d) The Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. In consideration for the sum of **SIX HUNDRED FORTY FIVE THOUSAND PESOS (Php 645,000.00)** or such other sums as may be ascertained, **TIMEFREE INNOVATIONS, INC.** agrees to perform works for the **ECTM CLOUD SERVICE** in accordance with his/her/its Bid.
6. The **NATIONAL COMMISSION ON MUSLIM FILIPINOS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding




