AN EN BANC RESOLUTION ON THE CONDUCT OF PROGRAM FOR AND DISTRIBUTION OF IFTAR FOR RELIGIOUS COMMUNITIES, DIGNITARIES, AND PARTNER AGENCIES

**WHEREAS**, RA 9997, mandates the NCMF to be the primary government agency to promote and maintain the integrity, values, culture, and well-being of Muslim Filipinos geared towards national unity and development and dedicated to empower Muslim Filipinos through multi-sectoral unified efforts guided by Islamic values and principles;

WHEREAS, during the month of Ramadhan, prayer and alms-giving is an opportune time to embody the values of discipline, reverence, and humility;

WHEREFORE, BE IT RESOLVED, as is hereby resolved that the Commission En Banc members hereby requests the Finance Management Service (FMS), to allocate 1.5 Million for the distribution of iftar to religious communities and 500 Thousand Pesos for the Iftar program for the dignitaries and partner agencies subject to availability of fund and in accordance to government audit rules and regulation;

**RESOLVED FURTHER**, that the Bureau of Muslim Cultural Affairs (BMCA) is hereby instructed to plan and organize an iftar program for the Commission;
