AN ENBANC RESOLUTION APPROVING THE LIST OF SUPERVISORY AND MEDICAL TEAM MEMBERS ENDORSED BY THE SELECTION COMMITTEE PURSUANT TO THE NCMF HAJJ OPERATIONS MANUAL OF 2023 AND OFFICE ORDER NO. 322005 DATED 21 MARCH 2022

WHEREAS, it is the policy of the State to ensure the rights and well-being of Muslim Filipinos with due regard to their beliefs, customs, traditions and institutions, as well as to further ensure their contribution to national goals and aspirations and to make them active participants in nation-building;

WHEREAS, the Commission is empowered by law to administer all programs, projects and activities, formulate the necessary rules and regulations, and coordinate with pertinent offices to ensure the success of the annual Hajj (pilgrimage) to Mecca, Kingdom of Saudi Arabia;

WHEREAS, the NCMF is mandated by law to administer and manage the Hajj pilgrimage of Filipino pilgrims in the Kingdom of Saudi Arabia under Section 8 (q) of Republic Act No. 9997;

WHEREAS, the NCMF adopted the Hajj Operations Manual of 2023 (Hajj Manual for brevity) having been approved on January 9, 2023 by the Commission En Banc and duly registered on January 25, 2023 at the Office of the National Administrative Register (ONAR) in the University of the Philippines Law Center;

WHEREAS, pursuant to the Hajj Manual, a Committee shall be created for the selection of the members of the Supervisory Group to be chaired by the Secretary or his authorized representative. The composition thereof shall be determined at the time of the issuance of the Office Order;

WHEREAS, the Secretary issued Office Order 322005 dated 21 March 2022 entitled "Creation of the 2023 NCMF Hajj Supervisory and Medical Team members Selection Committee and Guidelines";

WHEREAS, the Selection Committee presented its Resolution to the En Banc endorsing the result of its deliberation of applicants conducted on May 5 and 10, 2023 for approval of the Commission En Banc;

NOW, WHEREFORE, the Commission **RESOLVES** as it is hereby **RESOLVED**, that the Memorandum submitted by the Selection Committee through its Chairperson Commissioner Yusoph J. Mando and attested by the Committee Secretariat indicating the result of its deliberation on the composition of the members of the regular Supervisory and Medical Team for Hajj 2023 BE **APPROVED** subject to availability of funds.


