RESOLUTION NO. 16, SERIES OF 2023

**AN ENBANC RESOLUTION APPROVING THE ADDITIONAL ALLOWANCE
OF THE 2023 HAJJ ADVANCE TEAM TO MAKE IT UNIFORM WITH THE
ALLOWANCE OF SUPERVISORY TEAM**

WHEREAS, it is the policy of the State to ensure the rights and well-being of Muslim Filipinos with due regard to their beliefs, customs, traditions and institutions, as well as to further ensure their contribution to national goals and aspirations and to make them active participants in nation-building;

WHEREAS, the NCMF is mandated by law to administer and manage the Hajj pilgrimage of Filipino pilgrims in the Kingdom of Saudi Arabia under Section 8 (q) of Republic Act No. 9997;


WHEREAS, pursuant to the NCMF Hajj Operations Manual of 2023, the Secretary issued Office Order Office Order Nos. 0523093 and 0523102 creating the 2023 Hajj Advance Team as well as Supervisory and Medical Team, respectively;

WHEREAS, the Advance Team was provided an allowance of Sixty Thousand Pesos (P60,000.00) covering two (2) months whereas the Supervisory and Medical Team was provided with Forty-Five Thousand Pesos (45,000.00) covering one (1) month;

WHEREAS, there is a need to make the allowances and entitlements of all frontliners in the KSA-leg of the 2023 Hajj Operations uniform and commensurate with the tasks assigned;

NOW, WHEREFORE, the Commission **RESOLVES** as it is hereby **RESOLVED**, to urge the Office of the Secretary to issue an order directing the Finance Management and Services (FMS) to release to the members of the 2023 Hajj Advance Team the differential in their allowance in the amount of Thirty Thousand Pesos (P30,000.00) each to make it uniform to that received by the Supervisory Team. The FMS is further directed to immediately process and release funds while the members of the Advance Team are in Saudi Arabia.
