**(SUPPLY AND DELIVERY OF INFLUENZA VACCINES**  
**FOR 2023 NCMF HAJJ OPERATIONS)**

**KNOW ALL MEN BY THESE PRESENTS:**

This AGREEMENT is made and executed this APR 20 2023 day of \_\_\_\_\_ 2023 by and between:

The **NATIONAL COMMISSION ON MUSLIM FILIPINOS**, a government entity created by virtue of R.A. No. 9997, with principal office address at 79 Jocfer Annex Building, Commonwealth Avenue, Diliman, Quezon City herein represented by its Secretary, **GUILING A. MAMONDIONG**, hereinafter referred to as the **NCMF**;

- and -

**PHARMA QUEST CO.**, a company duly organized and existing under the laws of the Philippines with principal office address at 46A Kalantiaw Street, Barangay Masagana, Project 4, Quezon City, duly represented herein by its Operations Manager, **MARGERY M. FILIO**, hereinafter referred to as the **SUPPLIER**;

WITNESSETH

WHEREAS, on April 13, 2023 the **NCMF** invited Bids for the **Supply and Delivery of Influenza Vaccines for 2023 NCMF Hajj Operations (Reference No. NCMF-IB-No. 2023-003)** with ancillary services appurtenant thereto, with an ABC of **Five Million Four Hundred Thousand Only (PhP 5,400,000.00)**;

WHEREAS, in response to the said Invitation to Bid, the **SUPPLIER** has submitted its bid for the **Supply and Delivery of 6,000 dose Influenza Vaccines for 2023 NCMF Hajj Operations**, bidding for the same, in the amount of **Four Million One Hundred Sixty Four Thousand Only (PhP 4,164,000.00)** and latter declared as the lowest calculated and responsive bid (hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read into and construed as part of this Agreement, viz.:

- (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the **NCMF** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the **NCMF** to provide the aforementioned vaccines and services related thereto and to remedy defects therein, if there is any, in conformity in all respects with the provisions of the Contract.

4. The **NCMF** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the above-mentioned vaccines and services related thereto and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.



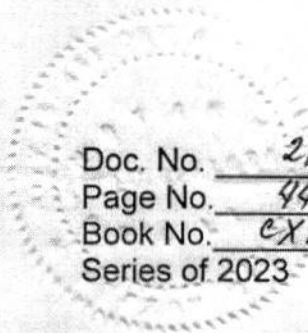
