

CONTRACT AGREEMENT

(SUPPLY AND DELIVERY OF MENINGOCOCCAL VACCINE FOR THE 2024 HAJJ PILGRIMS)

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made the day of APR 27 2024 20____ between **NATIONAL COMMISSION ON MUSLIM FILIPINOS** of the Philippines (hereinafter called "the Entity") of the one part and **PHARMA QUEST CO.** of Quezon City, Philippines (hereinafter called "the Supplier") the other part;

The **NATIONAL COMMISSION ON MUSLIM FILIPINOS**, a government entity created by virtue of R.A. No. 9997, with principal office address at 79 Jocer Annex Building, Commonwealth Avenue, Diliman, Quezon City herein represented by its Secretary, **SABUDDIN N. ABDURAHIM**, hereinafter referred to as the **NCMF**;

- and -

PHARMA QUEST CO., a company duly organized and existing under the laws of the Philippines with principal office address at 46A Kalantiaw Street, Barangay Masagana, Project 4, Quezon City, duly represented herein by its Operations Manager, **MARGERY M. FILIO**, hereinafter referred to as the **SUPPLIER**;

WHEREAS, the **NATIONAL COMMISSION ON MUSLIM FILIPINOS** invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Meningococcal Vaccine for the 2024 Hajj Pilgrims** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Eight Million Two Hundred Eighty Four Thousand Only (PhP 8,284,000.00)**



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of the Agreement, viz.:

- i. Philippine Bidding Documents (PBD's):
 - i. Schedule of Requirements;
 - ii. Technical Specifications
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental of Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including documents/statements contained in the Bidder's bidding envelopes as annexes, and all other documents submitted (e.g., Bidders response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the bidder's conforme thereto: and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. **Winning bidder agrees that additional contract documents or information prescribed by the GPPD that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**



3. In consideration of the sum of **Eight Million Two Hundred Eighty Four Thousand Only (PhP 8,284,000.00)** or such other sums as may be ascertained, **PHARMA QUEST CO.** agrees to Supply and deliver meningococcal vaccines in accordance with its Bid;
4. The **NATIONAL COMMISSION ON MUSLIM FILIPINOS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
