THIS AGREEMENT made this AUG 16 2024 day of 2024 between;

NATIONAL COMMISSION ON MUSLIM FILIPINOS, is a government agency located at 79 Jocfer Building, Commonwealth Avenue, Diliman, Quezon City, represented herein by its Secretary, **SABUDDIN N. ABDURAHIM** hereinafter referred to as the "ENTITY"

- and -

DOÑA ALEJANDRA INC. (DAI) is a private corporation duly organized and existing under the laws of the Republic of the Philippines, with office address located at G/F ESNA Bldg. #30 Timog Ave. Quezon City, represented herein by its, President / CEO, **BENIGNO EMILIO P. RAMIREZ** hereinafter called the "SUPPLIER".

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the ***Delivery, Installation, Testing and Commissioning of the Government Human Resource and Payroll Information System (GHRPIS)*** and has accepted a Bid by the Service Provider for the services in the sum of ***EIGHT MILLION TWO HUNDRED FORTY-TWO THOUSAND EIGHT HUNDRED PESOS ONLY (Php8,242,800.00)*** hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:





1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract;
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the

bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of ***Eight Million Two Hundred Forty-Two Thousand Eight Hundred Pesos (PhP8,242,800.00)*** or such other sums as may be ascertained, **DOÑA ALEJANDRA, INC. (DAI)** agrees to provide the goods and services in accordance with his/her/its Bid.
4. The **NATIONAL COMMISSION ON MUSLIM FILIPINOS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
