## **COMMISSION EN BANC** RESOLUTION NO. 21 SERIES OF 2024

AN EN BANC RESOLUTION AUTHORIZING THE COMMISSIONERS OF THE NATIONAL COMMISSION ON MUSLIM FILIPINOS (NCMF) TO ESTABLISH SATELLITE OFFICES IN THEIR RESPECTIVE ETHNOGRAPHIC REGIONS TO PROVIDE TOP-NOTCH SERVICE FOR THEIR RESPECTIVE ETHNOGRAPHIC BACKGROUNDS

WHEREAS, the National Commission on Muslim Filipinos (NCMF) is mandated to promote the welfare and development of Muslim Filipinos, which includes understanding and addressing their diverse needs across different ethnographic backgrounds;

WHEREAS, the effectiveness of the NCMF's programs and services can be significantly enhanced by having a more localized presence in various ethnographic regions, enabling better engagement and tailored support for the communities;

WHEREAS, the establishment of satellite offices in key ethnographic regions will allow the commissioners to directly oversee and manage initiatives that are culturally and contextually appropriate, ensuring that services are delivered in a manner that is sensitive to local customs and needs;

NOW, THEREFORE, BE IT RESOLVED, by the Commission En Banc of the National Commission on Muslim Filipinos (NCMF), that the commissioners are hereby authorized to establish satellite offices in their respective ethnographic regions, subject to availability of funds.

**BE IT FURTHER RESOLVED,** that these satellite offices shall be tasked with:

Providing Top-Notch Service: Delivering high-quality services tailored to the unique needs and cultural contexts of the respective ethnographic backgrounds.

Enhancing Local Engagement: Strengthening relationships and communication with local communities to better understand and address their specific concerns.

Supporting Regional Programs: Implementing and managing programs that are designed to meet the needs of the ethnographic region effectively.

Ensuring Effective Oversight: Facilitating better oversight and management of NCMF activities and resources within the ethnographic regions.

BE IT FURTHER RESOLVED, that the necessary budget, resources, and support be allocated to the establishment and operation of these satellite offices to ensure their effectiveness and sustainability.

**RESOLVED**, that this resolution shall take effect immediately upon its approval.
