ABDURAHIM TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE
LANDBANK OF THE PHILIPPINES AS AUTHORIZED GOVERNMENT
DEPOSITORY BANK (AGDB) FOR PURPOSES OF COLLECTION AND
PROCCESSING OF HAJJ FEES FOR 1446H/2025G HAJJ SEASON

**WHEREAS**, Section 8 (q) of Republic Act No. 9997, otherwise known as *National Commission on Muslim Filipinos Act of 2009* to, the Commission is mandated to "administer all programs, projects and activities, formulate the necessary rules and regulations, and coordinate with pertinent offices to ensure the success of the annual Hajj (pilgrimage) to Mecca, Kingdom of Saudi Arabia";

**WHEREAS**, Section 11(e) of the same law authorizes the NCMF through the Bureau of Pilgrimage and Endowment (BPE) to "formulate the necessary guidelines to ensure the timely processing of the pilgrim's travel documents and the equitable and reasonable collection of fees. Such collection shall be limited to mutawifl and pass porting and/or processing fees only. Collected fees shall be deposited in a special trust fund which shall be established by the Commission the expenses from which shall be subject to existing auditing laws, rules and regulations";

WHEREAS, Republic Act No. 12116, otherwise known as the General Appropriations Act (GAA) for Fiscal Year (FY) 2025, under the title **Special Hajj Fund** provides that "Advance payments by pilgrims and local and foreign donations received to cover expenses for the annual Hajj shall be recorded as Special Hajj Fund as provided under R.A. No. 9997. Cash balances of the aforementioned fund, however, shall be covered by E.O. No. 338, as implemented by COA-DBM-DOF Joint Circular No. 1-97 dated January 2, 1997";

**WHEREAS,** the **LAND BANK OF THE PHILIPPINES** ("LANDBANK") is a 100% government-owned financial institution and an Authorized Government Depository Bank (AGDB) duly organized and existing by virtue of R.A. 3844, as amended, engaged in various banking services;
