Subject: 2025 HAJJ REGIONAL MOBILE VACCINATION PROGRAM SCHEDULE

The National Commission on Muslim Filipinos - Bureau of Pilgrimage and Endowment (NCMF-BPE), in collaboration with the Department of Health - Bureau of Quarantine (DOH-BOQ), hereby announces the schedule for the 2025 Hajj Regional Mobile Vaccination Program for all concerned participating Sheikhs and intending pilgrims, as detailed below:

Intending pilgrims following the regional schedule must pay vaccination fees by April 14, 2025. Failure to pay by this date will result in vaccination at the BOQ Central Station according to their schedule.

Requests for vaccination schedule or location changes must be made through your accredited Sheikh. The Sheikh will submit these requests to your HRPC for onward transmission to the NCMF Central Office.

Venue change requests will only be processed if payment was made by April 7, 2025. The deadline for submitting venue change requests is **April 15, 2025, at 12 noon.**

Your cooperation and prompt action on this matter are highly appreciated as we collectively work towards a successful and well-organized Hajj 2025 for all Filipino pilgrims.
