

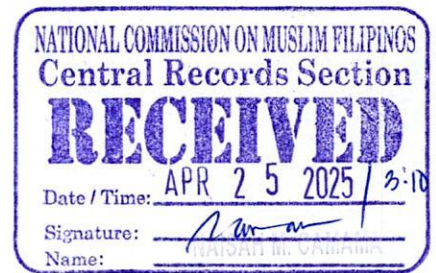

### **COMMISSION *EN BANC* RESOLUTION NO. 5 SERIES OF 2025**

**AN *EN BANC* RESOLUTION RENAMING THE COMMISSION'S MANAGEMENT COMMITTEE INTO THE COMMISSION'S "EXECUTIVE COMMITTEE" AND THEREAFTER CREATING A MANAGEMENT COMMITTEE COMPOSED OF THE COMMISSION'S SECRETARY, COMMISSIONERS, EXECUTIVE DIRECTOR, DEPUTY EXECUTIVE DIRECTOR, AND DIRECTORS OF ALL OPERATING UNITS**

**WHEREAS**, the Management Committee of the Commission in a resolution dated 28<sup>th</sup> of February, 2025, seeks to recommend to the Commission *En Banc* the creation of a Management Committee which will be headed by the Secretary of the Commission, and composed of the Members of the Commission *En Banc*, Executive Director, Deputy Executive Director and the Directors of all operating units;

**WHEREAS**, the Commission *En Banc* recognizes the wisdom behind the proposal that will enable the Commission to have a Committee that will have first-hand information on operational concerns and will allow for a streamlined implementation of policies developed by the Commission *En Banc*;

**WHEREAS**, the Commission *En Banc* likewise recognizes the need for a Committee that would address policy and program development which is essential in assisting the Commission *En Banc* in determining the policy direction needed by Commission as a whole for the benefit of the Muslim Filipinos;

**WHEREAS**, the Commission *En Banc* recognizes that an Executive Committee headed by the Secretary of the Commission, and composed of the Executive Director, Deputy Executive Director, Bureau and Service Directors of the Central Office is necessary in order to have operational efficiency;

**WHEREFORE, BE IT RESOLVED**, that the Commission's existing Management Committee shall hereon forth be renamed as the Commission's Executive Committee and shall retain its purpose, powers, functions and bound by the same existing Internal Rules.

**RESOLVED FURTHER**, as it hereby resolved that a Management Committee be created which shall convene once every quarter and be headed by the Secretary of the Commission and composed of the Commissioners, the Executive Director, the Deputy Executive Director and the Directors of all operating units under the Commission in order to create a forum where operational concerns of all operating units can be discussed,



monitored, adjusted and properly resolved with the aim of creating a more responsive Commission to the needs of its Filipino Muslim Constituents;

**RESOLVED FINALLY**, that for the purpose of addressing the internal rules and regulations of the newly created Management Committee, the same shall convene on **May 1, 2025** for its inaugural session to discuss and determine its internal rules. The Internal Rules of the now renamed Executive Committee shall be adopted until its own Internal Rules is passed.


